ASSUMPTION OF RISK ACKNOWLEDGMENT - MINOR
[Please Read Assumption of Risk Acknowledgment Carefully]

1. My name is _____. I am _____ years of age. I have completed an entry form and signed up to race in a motocross event through Great Plains Vintage Motocross, LLC at the Three Hills, Nebraska Motocross Track located at 6251 G Road, Nebraska City, Nebraska 68410 ("Three Hills") for all events during the _____ season. The event or events that I have entered involve my operation and racing of a motocross bike in one or more motocross events against other participants who may be younger or older than me with varying levels of skills. I am entering the race in order to race as fast and efficiently as I am able in order to finish each race as high on the leaderboard as possible. I also understand and acknowledge that when I am not racing a motocross bike, I will be spectating, waiting and otherwise visiting various areas of Three Hills including, but not limited to, restricted areas. I understand there are certain dangers not only in motocross racing but also in just spectating and being in the vicinity of motocross races that can lead to injuries including, but not limited to, disability and even death.

2. I am an experienced motocross racer and have the ability to race against others of lesser and greater age, and of lesser and greater capabilities.

3. I AM FULLY AWARE AND UNDERSTAND THAT IF I RACE AT ONE OR MORE MOTOCROSS EVENTS, THAT:

a. MINORS BELOW THE AGE OF 16 ARE STRICTLY PROHIBITED FROM COMPETING IN ANY EVENTS AT THREE HILLS AND I WILL NOT PARTICIPATE IN ANY MANNER IN ANY EVENT IF I AM BELOW THE AGE OF 16.

b. I MAY BE INJURED DUE TO MY OWN ACTIONS, MY OWN INACTIONS, THE ACTIONS OR INACTIONS OF OTHER RIDERS PARTICIPATING IN THE MOTOCROSS EVENT, THE RULES OF THE EVENT, THE GENERAL DANGEROUS NATURE OF THE EVENT INCLUDING HIGH-SPEED STRAIGHTAWAYS, CURVES, JUMPS, IRREGULAR AND RUTTY, WET OR DRY TRACK CONDITIONS, SPECTATOR INFERENCE, EQUIPMENT

FAILURE, IMPAIRED VISIBILITY AND A VARIETY OF OTHER FACTORS THAT MAKE THE SPORT OF MOTOCROSS RACING A DANGEROUS ACTIVITY.

c. I UNDERSTAND THAT SIMPLY BEING A SPECTATOR OF THE MOTOCROSS EVENTS AND OTHERWISE BEING IN THE VICINITY OF RESTRICTED AND NON-RESTRICTED AREAS, INCLUDING THE MOTOCROSS COURSE, I RUN THE RISK OF BEING INJURED BY OTHER PARTICIPANTS, DEBRIS AND EQUIPMENT RELATED TO THE MOTOCROSS RACING ACTIVITIES.

d. MY PARENTS HAVE GIVEN ME INSTRUCTION, GUIDANCE AND A GREAT DEAL OF EXPERIENCE IN THE SKILLS OF RIDING AND RACING A MOTORCYCLE FOR OFF-ROAD EVENTS INCLUDING MOTOCROSS AND ALONG WITH THE KNOWLEDGE AND TEACHINGS OF MY PARENTS, I HAVE BECOME VERY AWARE OF ALL RISKS INVOLVED.

e. NOTWITHSTANDING THE RISKS OF MOTOCROSS RACING AND THE RISKS OF BEING A SPECTATOR AND/OR VISITOR IN THE VICINITY OF MOTOCROSS RACING AT THREE HILLS, I BELIEVE THOSE RISKS ARE ACCEPTABLE TO ME AND I ASSUME ALL RISKS ASSOCIATED WITH MY PARTICIPATION IN ALL THREE HILLS MOTOCROSS EVENTS AND AS A SPECTATOR/VISITOR OF SUCH EVENTS INCLUDING THE RISK OF DEATH, DISMEMBERMENT, DISABILITY, LOSS OF QUALITY OF MY LIFE AND THESE INJURIES COULD AFFECT ME FOR THE REST OF MY LIFE.

4. BY SIGNING THIS DOCUMENT BELOW, I AM ACKNOWLEDGING AND ASSUMING ALL RISKS ASSOCIATED WITH MY PARTICIPATION IN ALL MOTOCROSS EVENTS AT THREE HILLS AS WELL AS BEING A SPECTATOR OR VISITOR AT THE THREE HILLS EVENTS.
